Regulations and other related documents adopted by all concerned Contracting Parties to implement Recommendation 21-08

In accordance with paragraph 236 of the *Recommendation by ICCAT amending the Recommendation 19-04 amending Recommendation 18-02 establishing a multi-annual management plan for bluefin tuna in the eastern Atlantic and the Mediterranean* (Rec. 21-08), in order to have greater transparency in implementing this Recommendation, the ICCAT Secretariat is mandated to biennially elaborate a report on the implementation of this Recommendation. Since this Recommendation entered into force in 2021, this report is presented for the first time at the Annual meeting of the Commission in 2023.
