Appendix 3

Comments received from CPC on the Table of Information for Panel 1

Comments from Belize

(ICCAT Circular 7079, circulated at request of Belize)

Belize wishes to notify the Secretariat and Panel 1 that the aspiration levels for our country for BET which we would like reflected in the tables is 2100 m/t which is consistent with our recent historical catches. Belize recalls that this was initially the catch limit set for developing counties in the 2014 recommendation for tropical tunas. The stocks were stable when catches were maintained at this limit and only began to experience increased fishing when the limit was raised to 3500 m/t.

It is clear, based on the comparisons on the table that Belize has the lowest BET allocation by purse seiner which has been surpassed by other regional players despite our historical presence and catches, number of vessels and compliance history and the fact that we are a coastal developing country. As a result, it is Belize's position that the level (2100 mt) to which we aspire is a fair and equitable limit for Belize to continue to develop its fisheries while maintaining stock status.

Comments from Canada

The information for Canada in **Appendix 1** is correct: we only have 3 longline vessels that meet the criteria for inclusion in the Register of Vessels. The reason for the difference is that Canada has 75 additional vessels permitted to retain bigeye but which are smaller than 20 m, and thus are not included in the register.

In reviewing Appendix 2, which uses Task 1 data to calculate recent average catches as defined in Rec. 19-02, paragraph 4, we noticed some inconsistencies in how average catches were calculated in cases where there were zero years. There are several CPCs under the four-year average formula that have zero catch years and should probably therefore be under the five-year formula: El Salvador, Fr-SPM, Guinée rep, Mixed flags (EU tropical), and Philippines. [Note from Secretariat: corrected in yellow on revised **Appendix 2**.]

As a suggestion, to frame the average catches in a context that reflects the variability of catches for each CPC, you could add a minimum and maximum column after the averages in Appendix 2. [Note from Secretariat: Included in **Appendix 2**.]

Comment from El Salvador

Following the format and guidance provided by the Secretariat, we wish to express that the catch level to which our country aspires, indicated in the corresponding column, should be 3,500 t, in accordance with my country's right to have access to the fishery in non-discriminatory conditions within the Convention area.

Comments from Guatemala

Guatemala wishes to inform the Secretariat and Panel 1 that we have reiterated our status as a coastal state ever since we have been part of this honourable Commission, indicating that the Republic of Guatemala aspires to a bigeye tuna catch limit of 3,500 t.

It is important to acknowledge and highlight that Guatemala is a developing state and the use of fishery resources as a coastal state contributes to and strengthens growing economies as regards sources of employment, provision of products and services, as the strengthening of Guatemalan economies involved in all the processes of developing the tuna fishery in the Atlantic, establishing that a limit of 3,500 t would greatly strengthen this country's development.

In this regard, we acknowledge the management measures and the fact that during the latest meetings we agreed to a limit of 1,827 t in the short term, and we would like the table of the working document to reflect that this is currently under discussion. Guatemala has never exceeded the assigned values and we have fulfilled all the Commission's management measures.

Guatemala wants the limit to be no less than 1,827 t of bigeye tuna, so that it may continue to develop this fishery.

Comment from Japan

We believe initial quotas would be more suitable to compare to TAC of 61,500. [Note from Secretariat – this has not been changed on the current version but figures may be included if provided by CPCs within the deadline.]

Comment from Morocco

In accordance with para 5 of Rec. 19-02, Morocco considers that the right and aspirations of coastal States to develop their fisheries must be respected and taken into consideration within the framework of development of the TAC allocation criteria, along with other criteria, in particular, the economic and social aspects, as raised by several CPCs during the second meeting of PA1 (1-3 September 2021), in order to ensure a fair and equitable distribution among all the members of this Panel.

Morocco would also like to highlight that the "historical catch" criterion which constitutes the basis for development of the attached document, cannot be considered the basis for discussions for revision of the bigeye tuna TAC allocation key, given that developing coastal CPCs will be heavily penalized, as raised and discussed at length during that meeting.

Comments from Russia

In the column Total number of vessels 2021, the number of purse seiners in 2021 in the line RUSSIA, please put 0 and 0. Russia in 2021, as in 2020, did not conduct a specialized fishery for tropical tuna. So far, no new application for tropical tuna fishing in 2021 and 2022 was placed at our disposal. [Note from Secretariat: As the original figures had been taken from the 2020 (not 2021) plan, the changes were accepted. As no original plan for 2021 was submitted, no revision was required.)

Comment from the Philippines

We do not have any current fishing effort in the ICCAT Convention area. However, we aspire to have at least one longline fishing vessel operating within the next two years. For it to be economically feasible, the Philippines will be seeking a catch limit of about 500 t. Hence, his submission. The Philippines had dutifully paid its membership contribution, even though we did not have any active fishing vessels in the ICCAT Convention area.

US Statement in response to Circular 6764/21

The United States would like to submit this statement regarding its bigeye tuna aspirational limit to provide some context to the updated information we are submitting in response to Circular 6764 and PA1-09B/July 2021.

The U.S. view remains unchanged: it is important to maintain the small harvester threshold of 1575 t in any future bigeye tuna allocation discussions. This threshold, which was included in Recommendation 16-01 and its predecessors, should continue to apply to CPCs with small, stable, historical bigeye fisheries that do not harvest juveniles.

Panel 1 has not yet had a comprehensive discussion about which CPCs should be included in the allocation key. In the view of the United States, any CPCs that are major harvesters, with recent catches above a certain threshold, or that have significant catches of juvenile bigeye tuna, should be included on the allocation key. CPCs that do not meet those two criteria should be excluded from the table, but still subject to appropriate constraints and capacity controls. If the Panel decides that all CPCs with bigeye catches should be included in the quota table, including the United States, we would have to determine our "aspirational" catch level, noting that neither the 1575 t threshold, nor the 2100 t threshold in place prior to 2015, were ever binding limits.

Comment from Chinese Taipei

The recent average catch for Chinese Taipei is 13671.3 tons, as indicated in the Appendix 2, and we have therefore added such figure into the cell accordingly. In addition, our number of longliners in 2021 is the same as the total number of vessels 2021, that is 84, with the same footnote that was kindly inserted by the Secretariat. Hence, revision is also made to the corresponding cell. The column of "level aspired" is filled in as well.

Comment from Suriname

Suriname did not send a fishing plan because we do not have our own operating tuna fleet yet. Therefore, there are no catches to report. This is also stated in our submitted Annual report.
