#### INFORMATION ON FADS

Submitted by ICCAT Secretariat

This document contains two sets of information: 1) FAD data 2010-2020 and 2) Difference in levels of fishing on FADs between years 2018 and 2019.

# 1. FAD Data: Summary and review of the FOB/FADs deployed based on ST08-fadsdep reports (ICCAT database) between 2010-2020

The ICCAT FADs database contains the information submitted annually by CPCs in the ST08-FADsDep since 2014. However, due to the changes in the FOB/FADs data requirements, the ST08-FADsDep e-form was modified in 2017.

As intended, the FAD Management Plan of the Commission aims primarily to monitor fishing activities of tropical tunas. Following the PA-1 Intersessional meeting **Table 1** presents a summary by year (2010-2020) and by Flag of the reported catches of tropical tunas (SKJ, BET, YFT) in Task 1 and 2 CE by fishing mode and the corresponding number of FOB/FADs deployed by year and flag through ST08-FADsDep form.

## 2. Fishing Levels on FADs 2018 vs 2020

Rec. 19-02, para 31, stipulates that each CPC with purse seine fishing vessels is encouraged not to increase its total fishing effort on FADs from its 2018 level. **CPCs shall report the difference between the 2018 level and the 2020 level to the 2021 Commission meeting.** Below are the extracts from the Annual Reports of requirement M: TRO19 (Difference between fishing effort 2018 and fishing effort 2020). Only those reporting purse seine fisheries using FADs (shaded cells) have been translated; the others are in original language only.
