# ICCAT Workshop on Shark Research and Data Collection Programme - SRDCP (hybrid/Secretariat, Madrid, Spain, 13-15 July 2023)

#### **Background**

In 2012 the Shark Species Group (SSG) recommended the development of a Shark Research Programme. The main objectives of the programme were discussed and established during the 2013 Intersessional Meeting of the Shark Species Group. During the 2014 Commission meeting, it was decided to assign funds to the Shark Research and Data Collection Programme (SRDCP). In 2015, during the Blue Shark Data Preparatory Meeting, the SSG reviewed the proposal for implementation of the SRDCP that had been prepared in 2014 and identified national scientists who would be in charge of preparing proposals for receiving funds to carry out each of the research topics listed in the original proposal. During the 2015 Blue Shark Stock Assessment Meeting and shortly thereafter, four draft proposals covering different aspects of the life history, population structure, and fisheries of shortfin mako (Isurus oxyrinchus) were presented: a pan-Atlantic age and growth study; a population genetics study to investigate the population structure and phylogeography; a post-release mortality study focusing on pelagic longline fisheries; and a satellite tagging study for determining movements and habitat use. For the first three years the programme focused on these proposals and contemplated extensive collaborative work among national scientists with the aim of contributing information to the 2017 Shortfin Mako Stock Assessment. Activities under the SRDCP have continued since inception and have been extended to include other shark species such as porbeagle, silky shark, oceanic whitetip shark, longfin mako and hammerheads. In 2022, during the Intersessional Meeting of the Shark Species Group, it was discussed that it would be important to do a thorough assessment of the achieved results of SRDCP, to review its ongoing activities, to define future steps, and to establish the objectives for the next phases. For this purpose, the Group recommended that a workshop should be held in 2023.

#### **Objective**

To review the SRDCP status, results achieved, ongoing activities, and to establish the objectives for the next phases.

#### **Target participants**

The target participants are scientists who have direct involvement with the SRDCP activities. However, the workshop is open to any interested SCRS scientists.
