### Second Intersessional Meeting of Panel 4 on North Atlantic Swordfish MSE

In 2023, the Commission is scheduled to adopt a management procedure for North Atlantic swordfish based on a set of Candidate Management Procedures (CMPs) reported by the SCRS from the Northern Swordfish Management Strategy Evaluation process. After review of the MSE framework in March 2023, Panel 4 provided feedback on operating model (OM) structure, performance metric thresholds, and CMP specifications. The objectives of this meeting are i) for the SCRS to update Panel 4 on recent modifications to the OM set; ii) for the SCRS to present results from initial CMP tunings; iii) for Panel 4 to operationalize management objectives and refine key performance metrics, including time frames for tuning objectives; and iv) for Panel 4 to identify minimum threshold TAC changes.
