SUBJECT: MEETING OF THE STANDING COMMITTEE ON RESEARCH AND STATISTICS (SCRS) (hybrid/Madrid (Spain), 23 - 27 September 2024)

On behalf of the Chairman of the International Commission for the Conservation of Atlantic Tunas (ICCAT), I should like to inform you that the Standing Committee on Research and Statistics (SCRS) will hold its 2024 meeting in hybrid format, from 23 to 27 September 2024. The in-person meeting will be held in Madrid (Spain), at the Hotel Chamartín The One. In this regard please find here attached a letter from the SCRS Chair.

In order to carry out the preparatory work, the Subcommittee on Statistics and the Species Groups will also meet in a hybrid format, during the preceding week in Madrid, at the Hotel Chamartín The One (16-21 September 2024). Interpretation will be provided for the meetings of the Subcommittee on Statistics and Species Groups of albacore, tropical tunas and billfishes.

The Tentative Agendas for the SCRS Plenary, the Subcommittee on Statistics and the Species Groups meetings as well as other relevant information are attached herewith. The SCRS timetable will be made available at a later stage on the ICCAT current meetings webpage. However, please note that a meeting is scheduled for Heads of Delegation at 8:30 (Madrid time) on 23 September 2024.

Please note that our mailing distribution list is limited. Therefore, I should like to ask that you circulate this announcement to potential delegates. This announcement will also be placed on our website. Documents for general distribution which become available before the meeting will also be placed on the website.

Funding is available to cover travel and subsistence expenses for a limited number of national scientists from developing States that are Contracting Parties and that can provide information relevant to the meeting objectives. According to the Rules of Procedure for the Administration of the Special Meeting Participation Fund adopted at the 2023 Commission meeting, requests should be received **45 days in advance** (**2 August** for the Subcommittee on Statistics and Species Groups, and **9 August** for the SCRS Plenary meeting). Requests for financial assistance cannot be accepted after these dates. All the information related to the ICCAT special funds for participation in ICCAT meetings and capacity building is available on the ICCAT website. It is highly recommended to visit this webpage in advance and to strictly follow the protocols. In particular, it is necessary to fully complete the invitation form including **explanations of the expected contribution to the meeting** and how it relates to the meeting objectives. These latter documents should be sent to ICCAT-Travel@iccat.int.

In order to organize the meetings in advance of the sessions, in particular, regarding the number of in-person participants, you are kindly requested to send to the ICCAT Secretariat a list of delegates who will participate in the SC-STATS, Species Groups and SCRS Plenary meeting by **30 August 2024**. Any late submission of the official delegation may cause delay in providing access to participants to the meeting and to the related documents. Participants must also register for the meetings by **6 September 2024**, at the latest, using the online registration form which will be shortly available on the current meetings page of our website.

Dear colleagues,

I look forward to seeing you all, both those participating in person and those joining online, at the September Species Group meetings and the SCRS Plenary. I'd like to take this opportunity to highlight for your awareness several aspects of these meetings.

First, I would like to point out that we will once again have the benefit of interpretation during the Species Group week for selected Groups and days. As we have seen, I expect that this will greatly facilitate the engagement of scientists in these very important discussions. Check the Species Group week schedule for which sessions will have interpretation.

Also, a reminder that the posted agendas do not necessarily represent the order in which items will be covered during the meetings. During Species Group meetings the order may be affected by the timing of availability of Secretariat Statistics Department staff to present the current data (since up to three meetings will be held simultaneously each day) and other logistical factors that the Chair of each meeting must have the flexibility to address. So, if you will be participating online, please take this into account.

The SCRS Plenary agenda follows the structure of the SCRS Annual Report. But we will be taking the same approach as last year in scheduling when topics will be covered. Each Species Group and Subcommittee will be assigned an initial block of time during which to cover all of their components of the SCRS Report. This initial schedule will be made available in advance of the SCRS Plenary. During the course of the SCRS Plenary, revised schedules may be posted, as needed, to accommodate incomplete presentations and discussions, as well as the availability of revised Report sections requiring a second review.

During the 2023 SCRS Plenary meeting, there was agreement to no longer include summaries of intersessional meetings within the SCRS Annual Report. It is always recommended to review the reports of intersessional meetings in advance of the SCRS Plenary, but the absence of these summaries highlights the importance of being familiar with these intersessional meetings reports for our discussions to be efficient and productive.

Finally, we will be considering a new format for Executive Summaries for endorsement by the SCRS this year. Please take the time to review the new format and example Executive Summaries once they are posted in advance of the meeting.

I am excited that all of you will have the chance to review all of the excellent intersessional work that has been undertaken this year by SCRS scientists, and to participate in the finalization of the scientific advice to the Commission.

Call for Scientific Papers

Participants in the Species Groups and/or the SCRS meetings are encouraged to submit relevant scientific papers. The titles and names of authors of papers should be submitted to ICCAT (info@iccat.int) as soon as possible, but at least two weeks in advance of the meeting so that Rapporteurs can plan the sessions. The electronic versions of the documents and presentations, if any, shall be submitted at least **one week** before the beginning of the corresponding meeting, to give the ICCAT Secretariat time to organize the work and to make information available to participants in advance of the meeting. Documents submitted after the deadline i.e., one week in advance of the meeting could be deferred to next year for discussion. Authors are reminded to closely follow the Guidelines for Authors of Scientific Documents for the ICCAT SCRS and Collective Volume Series. Documents can be presented in PDF format, although the original documents (text, tables and figures) should be prepared in MS Word or compatible software.
