2025 Shortfin Mako Data Preparatory Meeting

(Málaga, Spain – 10-14 March 2025)

Objectives

The long-term objectives for the Shark Species Group in 2025 are to conduct a stock assessment for the North and South Atlantic stocks of shortfin mako shark, continue the research activities as defined in the Shark Research and Data Collection Program (SRDCP) and assess the achieved results.

Accordingly, the main objective of this meeting is to review, compile and prepare the data for the June 2025 Shortfin Mako Shark Stock Assessment Meeting. In addition, an update of the most recent activities within SRDCP will be presented and discussed aiming to achieve the goals set 2025.

3. Language

Following the decision and Recommendations from the Commission and SCRS in 2024, language interpretation will be provided during the meeting.

4. Call for scientific papers and presentations

Participants are encouraged to submit relevant scientific papers. Following the latest SCRS deadlines for the submission of SCRS documents and presentations, for this meeting, they should be provided to info@iccat.int and/or nathan.taylor@iccat.int by **3 March 2025**. Documents and presentations provided after the latter deadline will not be accepted unless previously authorized by the Chair(s). Authors are reminded to closely follow the [Guidelines for Authors of Scientific Documents for the ICCAT SCRS and Collective Volume Series](#). Furthermore, the original documents (text, tables, and figures) should be prepared in WORD or compatible software.

5. Provision of data

CPCs are requested to submit updates of Task 1 and Task 2 data already reported (up to the year 2023) at least two weeks before the start of the meeting (**21 February 2025**).

Individual standardized catch per unit effort (CPUE) indices until 2023 should be provided for the Atlantic stock. Since the Working Group on Stock Assessment Methods (WGSAM), established standard criteria to evaluate standardized catch rates, it is recommended that authors of documents on standardized CPUEs follow the instructions defined by the WGSAM describing the information required to facilitate the appropriate construction and evaluation of CPUE series.



6. Registration

Participants are kindly requested to register for the meeting by **28 February 2025** at the latest. Early registration is essential for the ICCAT Secretariat to ensure the setting up of the online platform. **Online registration** must be completed through the [ICCAT meetings page](#) or the Registration form.
