#### SUBJECT: BLUEFIN TUNA SPECIES GROUP INTERSESSIONAL MEETING (Hybrid/Sète, France, 8-11 April 2025)

#### Bluefin Tuna Species Group Intersessional Meeting (Hybrid/ Sète, France, 8-11 April 2025)

## **Objectives**

To review the western bluefin tuna (BFT-W) Close-Kin Mark Recapture (CKMR) study, to discuss further steps to complete the eastern (BFT-E) CKMR feasibility study, to evaluate new information that may be consequential for the Management Strategy Evaluation (MSE), and to refine the plans for the 2026-2027 stock health check and MSE review.
