HISTORY OF ACTIONS TAKEN BY THE COMMISSION FOLLOWING REVIEW BY THE COMPLIANCE COMMITTEE SINCE 2009

In 2009, the Compliance Committee began a review by individual CPCs, rather than by theme as previously. COC-308 is an Excel file which has the columns for previous years hidden, in order to allow for a print of the last two years. However, it was previously agreed by the COC that compliance history should be taken into account when considering actions to be taken regarding CPC.
