REPORT ON THE IMPLEMENTATION OF THE ICCAT REGIONAL OBSERVER PROGRAMME FOR EAST ATLANTIC AND MEDITERRANEAN BLUEFIN TUNA

The Regional Observer Programme for eastern Atlantic and Mediterranean bluefin tuna (ROP-BFT) is carried out under the provisions of the *Recommendation by ICCAT amending the Recommendation 13-07 by ICCAT to Establish a Multi-annual Recovery Plan for Bluefin Tuna in the eastern Atlantic and Mediterranean* [Rec. 14-04]. The provisions of this Recommendation stipulate that observers are to be placed by the Secretariat to ensure observer coverage of 100% of purse seine vessels during all the annual fishing season. In this respect, an observer shall be present during the fishing operation; and during all transfer of bluefin tuna to the cages and all harvest of fish from the cage; and during all transfers of bluefin tuna from traps to transport cages.

Implementation in 2015

Following a call for tender for the implementation of the Programme and a review of tenders by the selection committee the Commission again awarded the contract to the consortium MRAG/COFREPECHE. The Report of this consortium, available as **Annex 1 (summary attached as Appendix 1)**, contains more details on the implementation of the programme.

There were a total of 122 observer deployments on purse seine vessel in 2015. Ten CPCs participated in the programme. The list of vessels participating in the programme is attached as **Table 1**.

Since 2009, 295¹ farm deployments and eight trap deployments have been requested, as shown in **Table 2**. The list of farms and traps which currently participate in the programme is attached as **Table 3**. Anomalies remain, with farms continuing on the list of authorised farming facilities even though they do not participate in the ROP programme.

All observer reports have been made available to CPCs as **Annex 1 and 2 to COC-305/15**. The submissions from the CPCs involved in relation to any issues of non-compliance are contained in **COC-305/15**.

Implementation difficulties in 2015

Given the amount of work which ROPs generate, and the logistical complications inherent in such programmes, the Secretariat should like to request that the established procedures be followed for observer requests.

Failure to follow the procedures of requesting deployments and extensions to approved deployments continues to cause difficulties in the implementation, e.g. requests after 96 hours – in some cases one day before - requests for observers are not accompanied by proof of payment. It should be noted that the Secretariat cannot process any requests for which payment has not been made.

Some requests and payments for vessels were also received late. Completion of the section of the request for with details for any reimbursement is important, as in future this will be taken as official information for reimbursement of remnants at the end of the year.

In 2015, several requests for changes to disembark port were received. This causes significant logistical difficulties in addition to extra costs, particularly in cases where observers need visas. Complete and correct information at the time of request should be submitted, in order to make the necessary arrangements in advance

With regard to the international aspect of the programme, non-nationals were deployed as far as possible, with the exception of Turkish vessels given the provisions of bullet four, paragraph 5 of Annex 7 of Rec.14-04, as despite a persistent search, the consortium has been able to recruit only one qualified Turkish-speaking non-Turkish national.

Future implementation

It should be recalled that with the eBCD system, the observers will need an electronic signature to fill these eBCD sections. The digital certificates for the signatures will also have to be prepared well in advance so as not to delay the validation of the eBCD by the government authority, and hence CPC cooperation is requested in sending accurate information on observer needs as far in advance as possible, especially for farms and traps. If the dates of authorisation are not updated in the eBCD system following each request for extension, the observer will be unable to sign the BCD. Therefore, in addition to the time required by the consortium, the Secretariat needs to be informed sufficiently in advance to be able to enter the new dates in the system.
