EXPLANATORY NOTE ON THE ICCAT BUDGET FOR FINANCIAL YEARS 2016 AND 2017

In accordance with the provisions of Article X.1 and X.3 of the ICCAT Convention and of Article 2 of the Financial Regulations, the Secretariat must submit to the Commission for consideration and adoption the draft budget for the next two financial years 2016 and 2017.

The purpose of this note is to outline the proposed draft budget for 2016 and 2017, how it is structured, the line items of the different items as well as the impact on the contributions of ICCAT members.

1. Expenditure budget proposal

The proposal drawn up by the Secretariat for financial year 2016 includes an 11.32% increase compared to 2015, as well as a 2.00% increase for 2017 compared to 2016. This proposal is set out in **Table 1**.

The chapters and sub-chapters containing significant changes are outlined below:

- **Chapter 1 – Salaries.** It can be seen in the draft budget proposed that there is a significant increase in this chapter compared to 2015. The Secretariat proposes an 8.53% increase for the reasons set out below.

The latest recommendations adopted by the Commission have created new obligations for the Secretariat which has been stretched to the limits over the past 12 months. Consequently, it has been considered necessary to provide extra human resources so that it can effectively undertake the new tasks entrusted to it.

The substantial increase in tasks relating to the logistics of multiple meetings, both scientific and Commission, the management of financial assistance provided within the framework of Rec. 11-26 and in particular the implementation of new programmes and special funds (the Secretariat managed 16 trust funds in 2015) requires an increase in the workforce of the Department of Finance and Administration.

This is the reason why the Secretariat requests to hire a recruit in the General Services category.

Moreover, the proposal provides for the update of the United Nations salary scales for the Professional or higher categories (a 1.00% increase) and for the General Services category (a 2.90% increase for the salary scale and 5.00% for the pension scale). Given that the majority of the General Services staff is included in this chapter, this could have a significant effect.

Finally, it should be noted that since the adoption of the 2015 budget, from November 2014 to June 2015, the value of the United States dollar compared to the euro has increased around 15%, which has had a direct impact on the ICCAT staff pension plan, which is established in United States dollars.

- **Chapter 5 – Office equipment.** This chapter has been reduced by 51.94% on the basis of the forecast of lower equipment purchases in 2016.
- **Chapter 6 – Operating expenses.** This chapter has been reduced by 1.96% compared to 2015.
- **Chapter 8 – Coordination of research:**
 - a) **Salaries.** An increase of 3.85%, corresponding to the update of the United Nations salary scales and the increase in the value of the United States dollar compared to the euro, is proposed.
 - b) **Missions for improvement of statistics.** This sub-chapter has been reduced by 18.30% in order to adjust the budget to the costs incurred in the missions in 2014 and 2015.
 - f) **Telecommunications line – Internet domain.** There was an increase in expenditure in this sub-chapter in 2015; this is the reason why an 11.41% increase is proposed.
- **Chapter 10 – Separation from Service Fund.** The Secretariat presents a 50% increase in this chapter. This will enable the costs relating to the potential retirement of certain employees over the next two years to be covered.
- **Chapter 12 – Compliance.** The Secretariat proposes the creation of a new budgetary chapter called “Compliance”, so as to include in it the new expenditure directly associated with these functions.

The ICCAT Recommendations have increasingly been adding task to the work of the Secretariat. In addition to the staff resources required, this has resulted in increases in the creation and maintenance of data bases and cloud server hosting, which in some cases has necessitated contracting external services. In previous years, these expenditures were assigned to the chapter 8d), but true costs show that this has become insufficient to meet the needs of the Commission. This is due in particular to the technological requirements of these procedures.

The shortfall in some cases, particularly those expenditures relating to MCS measures, has been taken from the Working Capital Fund, but these costs are likely, at least in part, to be annual and fixed for the foreseeable future. Continued use of the Working Capital Fund for these costs will quickly lead to a substantial decline in the Fund, which must be maintained at a reasonable level in order to avoid financial difficulties of the Commission.

In addition, future requests by the Commission may include additional tasks which require new data base development, maintenance and server hosting which may go beyond the current capacity of the Secretariat.

For this reason the Secretariat has included an additional line item in the 2016/17 budget, to reflect the real costs of these items (Sub-chapter a) Maintenance of compliance data bases).

The modifications to the other chapters aim to round off the amounts.

2. Revenue budget proposal

The annual contributions relating to the 2016 and 2017 budget are shown in **Tables 3** and **5**, respectively, in accordance with Regulation 4 “Provision of funds” of the Financial Regulations and taking into account the expenditure proposal in point 1.

The draft budget for financial years 2016-2017 has been estimated on the basis of the most recent data available to the Secretariat. Regarding the economic possibilities of the member countries, the GDP per capita was used for 2012, published in the CADTM Handbook of Statistics 2014. In relation to the catch and canning data, the data reported by the Contracting Parties in response to ICCAT Circular #1519/2015 of 25 March 2015 have been used. For the Contracting Parties that have not reported data, the Secretariat has used the most recent data.

It should also be added that if the Commission adopts the recommendations of the Standing Committee on Research and Statistics (SCRS) with financial implications, the Secretariat will prepare another budget including these requests.

Finally, the Contracting Parties’ contributions will be revised at the 2015 Commission meeting to include the changes in Panel memberships, if any, and the update of the United Nations exchange rate which is used for their calculation (the July 2015 exchange rate has been used).
