At the last few meetings of the Commission, the Standing Committee on Finance and Administration (STACFAD) has stressed how important it is that Contracting Parties comply with their budgetary obligations so that the Commission can function properly, and has expressed its concern regarding non-payment by the Contracting Parties with outstanding debt. For this reason, in 2015 the Secretariat has continued the practice of recent years of sending two letters of reminder annually to the Contracting Parties with pending debt that have not complied with their budgetary obligations.

Although currently the number of Contracting Parties that owe past due contributions is still high, payments are being received from CPCs with past due debts from many years, which is perceived as some willingness of commitment by these Contracting Parties.

On the other hand, it should be noted that currently eight Contracting Parties are in a situation of having two years or more of arrears in the payment of contributions and hence face application of Article X of the ICCAT Convention referring to the suspension of voting rights.
