# REPORT ON THE IMPLEMENTATION OF THE ICCAT REGIONAL OBSERVER PROGRAMME FOR EAST ATLANTIC AND MEDITERRANEAN BLUEFIN TUNA

#### ICCAT Secretariat

The Regional Observer Programme for eastern Atlantic and Mediterranean bluefin tuna (ROP-BFT) is carried out under the provisions of the *Recommendation by ICCAT Establishing a Multi-annual Management Plan for Bluefin Tuna in the Eastern Atlantic and the Mediterranean Sea* [Rec. 18-02], as amended by *Recommendation by ICCAT Amending the Recommendation 18-02 Establishing a Multi-annual Management Plan for Bluefin Tuna in the Eastern Atlantic and the Mediterranean Sea* [Rec. 19-04]. The provisions of this Recommendation stipulate that observers are to be placed by the Secretariat to ensure observer coverage of 100% of purse seine vessels during all the annual fishing season. In this respect, an observer shall be present during the fishing operation; and during all transfer of bluefin tuna to the cages and all harvest of fish from the cage; and during all transfers of bluefin tuna from traps to transport cages.

## Implementation in 2020

Given the difficulties posed to international travel arising from the COVID-19 pandemic, some special procedures were proposed by the Commission Chair and agreed by the participants. These can be found in ICCAT Circular 2282/20.

The global pandemic has made 2020 a particularly challenging year for the implementation of the programme. In addition to the usual difficulties, i.e. the increasing number of participating vessels and the very short amount of time between the submission of information and embarkation of observers which causes difficulties both for the Secretariat and for the Consortium, further impediments were encountered in the distribution of equipment.

The Secretariat is pleased to report that ICCAT Regional Observers have been embarked on 187 of the 196 vessels for which requests for observer deployment were received. The only exceptions were:

- 1) One Maltese vessel; the observer assigned to this vessel withdrew from the deployment due to sickness but could not be replaced given the difficulties in mobilising observers from outside Malta and the scarcity of Maltese observers. The Maltese authorities assigned a national inspector to the vessel, and this inspector was assigned a temporary ROP number and provided all the necessary information at the end of the deployment.
- 2) Eight Norwegian vessels, as following a risk assessment carried out by the Norwegian authorities, it was determined that the risk of deploying external observers was too great. The alternative measures implemented by Norway are contained in COC-307/2020.
- 3) There were some unfortunate delays at customs of the equipment destined for the Tunisian and Libyan vessels which prevented the embarkation of the observers. These delays were beyond the control of the consortium, the Secretariat, and the Tunisian fisheries authorities. Following many attempts to unblock the situation, 39 Tunisian vessels were authorised by Tunisia to leave port to fish. On returning due to bad weather, all vessels were able to collect their observers with the equipment which had meanwhile been released. The report on the measures taken by Tunisia during this period is contained in in COC-307/2020.

The Secretariat's interim reports circulated during the season are contained in Appendix 1 to  ${\bf COC-307/2020}$ 

The list of vessels flagged to the ten CPCs participating in the programme is attached as  ${\bf Table}~{\bf 1}.$ 

Since 2009, 586¹ farm deployments and 21 trap deployments have been requested, as shown in **Table 2**. The list of farms participating in the programme is attached as **Table 3**, and a list of traps which were observed by regional observers contained in **Table 4**.

All observer reports have been made available to CPCs as Annex 1 and 2 to COC\_305/20. The submissions from the CPCs involved in relation to any issues of non-compliance are contained in COC 305/20.

The Consortium MRAG/COFREPECH continues to implement the Programme. The Report of this Consortium, available as **Annex 1** (Executive Summary attached as **Appendix 1**), contains more details on the implementation of the programme.

Failure to follow the procedures for requesting deployments on farms and extensions to approved deployments continues to cause difficulties in the implementation, e.g. requests after 96 hours – in some cases one day before or even the same day; or requests for observers are not accompanied by proof of payment. It should be noted that the Secretariat cannot process any requests for which payment has not been made. As travel becomes increasingly difficult, and the pandemic has resulted in many observers requiring testing before deployment, the amount of time between receipt of the request and the requested start date is clearly insufficient.

With regard to the international aspect of the programme, non-nationals were deployed as far as possible, but under the current circumstances, in most cases same-nationality observers were deployed.

The lists of potential non-compliance issues detected by observers on vessels, farms and traps are contained in the appendices to **COC-305/2020**.

## **Future implementation**

At present, no significant change is envisaged in the implementation of the ROP-BFT, unless required by any new measures adopted by the Commission. In the short term, early requests for deployment will facilitate timely deployment. The consortium will continue to test observers for COVID-19 before deployment.

#### Consortium's report on the implementation of the ROP-BFT

Executive Summary

The service provider for implementing year eleven (April 2020 / March 2021) of the ICCAT ROP-BFT (hereafter the Programme) comprises of a consortium led by MRAG based in London and COFREPECHE in Paris, assisted by regional partners located around the Mediterranean. This is the eleventh year that the Consortium has been awarded the contract to implement the Programme and experience gained in previous years has been used to enhance the systems in place for recruitment, training and deployment of observers and overall performance of the Programme.

The Programme allows the Commission to assess compliance with the regulatory framework. This report summarises the 186 deployments on authorised purse seiners during the 2020 fishing season, as well as the 35 farm deployments and 5 trap deployments completed to date since the start of the current contract. In addition, 50 farm deployments are included from the previous season.

One hundred percent observer coverage has been achieved on authorised purse seiners, farms and traps within the remit of the programme, which included monitoring all fishing, transfer, caging and harvesting activities with the exception of one observer who fell ill and was unable to be replaced, and the Norwegian fleet which has not had the deployment of ROP observers permitted by the Norwegian Authorities.

This report describes the key issues and developments in implementing the Programme in year eleven in line with the requirements. These are divided into operational and technical categories and provide perspective on issues that affected the observer role during deployments. The ability of observers to estimate numbers of tuna and comparisons with official estimates during transfer and caging operations are reviewed. Potential non-compliance events recorded by observers are summarised, including both those reported for transfer and caging operations as well as for general events.

This year was heavily impacted the COVID-19 pandemic, and the effect on the programme and measures taken by the consortium in cooperation with the Secretariat and respective CPCs are reviewed.

Furthermore, the Recommendation 19-10 was introduced in 2020 and placed specific safety requirement on the mobilisation of observers. This report provides details on how the consortium implemented these requirements.
