## STREAMLINING OF ICCAT CONSERVATION AND MANAGEMENT MEASURES

Given the difficulties of reaching decisions by correspondence, the Secretariat has not proposed any streamlining actions to the subsidiary bodies for 2020. Some issues remain pending from 2019, and may be discussed, if appropriate, in 2020. Below, in section 1, are listed the measures which were removed from the 2020 Active compendium as they were replaced by measures adopted in 2019 or removal had been agreed by the Commission at its meeting in 2019. Section 2 contains one measure which is being proposed for removal in the next Active Compendium as the actions adopted were limited in time and have now expired.

## 1. Recommendations and Resolutions deactivated due to specific provision or Commission decisions

[16-01] – Recommendation by ICCAT on a Multi-Annual Conservation and Management Program for Tropical Tunas

This Recommendation was repealed and replaced by Rec. 19-02, but has been left in the Active Compendium for 2020 for reference purposes.

[18-01] Recommendation by ICCAT Supplementing and Amending Rec. 16-01 on a Multi Annual Conservation and Management Programme for Tropical Tunas

Paragraph 68 of Rec. 19-02 stipulates that: This Recommendation [19-02] replacesRec.16-016 and 18-01andshall be reviewed by the Commission in 2021

[18-02] Recommendation by ICCAT Establishing a Multi-Annual Management Plan for Bluefin Tuna in the Eastern Atlantic and the Mediterranean Sea

Paragraph 120 of Rec. 19-04 stipulates that: This Recommendation [19-02] repeals and replaces Recommendation by ICCAT Establishing A Multi-annual Management Plan for Bluefin Tuna in the Eastern Atlantic and the Mediterranean (Rec.18-02).

[18-04] Recommendation by ICCAT to Replace Rec. 15-05 to Further Strengthen the Plan to Rebuild Blue Marlin and White Marlin Stocks.

Paragraph 25 of Rec. 19-05 stipulates that: This Recommendation [19-05] repeals and replaces the Recommendation by ICCAT to Replace Rec. 15-05 to Further Strengthen the Plan to Rebuild Blue Marlin and White Marlin Stocks (Rec. 18-04).

[16-12] Recommendation by ICCAT on Management Measures for the Conservation of Atlantic Blue Shark Caught in Association with ICCAT Fisheries

Paragraph 9 of Rec. 19-07 stipulates that: This Recommendation [19-07] repeals and replaces Recommendation by ICCAT on management measures for the conservation of Atlantic blue shark caught in association with ICCAT fisheries (Rec. 16-12).

[94-09] Resolution by ICCAT on compliance with the ICCAT conservation and management measures (including Addendum)

[97-11] Recommendation by ICCAT on transhipments and vessel sightings

Paragraph 8 of Rec. 19-09 stipulates that: This recommendation [19-09] replaces and repeals Resolution by ICCAT on Compliance with the ICCAT Conservation and Management Measures (Res. 94-09) and the Recommendation by ICCAT on Transshipments and Vessel Sightings (Rec. 97-11).

[18-11] Resolution by ICCAT Establishing a Pilot Program for the Voluntary Exchange of Inspection Personnel in Fisheries Managed by ICCAT

[12-10] Recommendation by ICCAT to Establish a Working Group to Develop Amendments to the ICCAT Convention
