POTENTIAL NON-COMPLIANCE ISSUES REPORTED BY REGIONAL OBSERVERS

1. Infractions reported by observers under the Regional Observer Programme for Transshipment

Seven incidences were reported as potential non-compliance as shown below. Responses to all were received. Where applicable, CPCs took follow up action; in some cases, no PNC was found and hence no action necessary. The details of the PNCs and the responses are contained in **Appendix 1**.
