**STREAMLINING OF ICCAT RECOMMENDATIONS***ICCAT Secretariat***Request for Removal of one Expired Recommendation**

The Recommendation by ICCAT Concerning the Implementation of an Atlantic Ocean Tropical Tuna Tagging Programme (AOTTP) [Rec. 14-02] remains active as it has not specifically been rescinded by any other measure.

This programme has been completed, and therefore the Recommendation is no longer applicable. The Secretariat seeks the Commission's endorsement for the removal of Rec. 14-02 from the Active Compendium.
