In accordance with the *Recommendation by ICCAT to replace Recommendation 03-20 on Criteria for Attaining the Status of Cooperating Non-Contracting Party, Entity or Fishing Entity in ICCAT* (Rec. 21-24), the Executive Secretary sent letters to the following: Dominica, Dominican Republic, Jamaica, Montenegro, Saint Lucia and St Kitts and Nevis.

Acknowledgement of the letter was received from St Kitts and Nevis. Saint Lucia submitted statistical data that were published prior to the issue of the Executive Secretary's letters. No other responses were received.

It is once again very reassuring to note that the Commission appreciates the transparency and commitment demonstrated by Gibraltar to provide all the necessary statistical data in relation to BFT as well as the management measures implemented in Gibraltar to date. In keeping with our continued commitment to fully cooperate with the ICCAT Secretariat, please note that BFT catch statistics (Form ST02-T1NC - Version 2024) pertaining to this year's BFT Open Season (2024) have been submitted by the Department to the email account stats\_info@iccat.int in accordance with ICCAT Circular 01071/2024.

By way of further information, an overview of the BFT Open Season statistics up to the 10 October 2024 have been provided in an **Appendix** to this letter. Additional catch data (if any) will be provided to the Secretariat once the season closes on the 14 October 2024.

We take this opportunity to once again firmly reiterate our strong desire to continue our cooperation and positive engagement with the ICCAT Secretariat moving forward, and to the consideration of the possibility of extending ICCAT to Gibraltar.
