#### Capacity building missions in ICCAT developing countries

(ICCAT Secretariat)

The second phase of the project Sustainable Management of Tuna Fisheries and Biodiversity Conservation in the Areas Beyond National Jurisdiction (Tuna-ABNJ2) funded by the Global Environment Facility (GEF) has approved the ICCAT requests for funding for several projects and the Letter of Agreement with the FAO has been signed.

In addition to Port Inspection Training, the Secretariat included a request to fund four Compliance Missions, over a period of five years in order to assist developing countries with the most difficulties in complying with the reporting requirements contained in ICCAT Conservation and Management measures.

In 2024, the Secretariat circulated a questionnaire to determine which CPCs would be interested in receiving such assistance through ICCAT Circular #7734/24, further to ICCAT Circular #2292/23.

To date, <u>three</u> requests have been received (<u>Angola</u>, Egypt and Trinidad and Tobago). One request has been updated (Senegal) at the request of the Secretariat, as the questionnaire was submitted last year and assistance has not yet been received. These requests are attached, and the Commission, as advised by the Compliance Committee, should determine the order of priority for these CPCs.

The Compliance Committee is therefore invited to review the requests and determine the most urgent case, in order to organize a compliance mission in 2025.
