## Regulations and other related documents adopted by all concerned Contracting Parties to implement Recommendation 22-08

In accordance with paragraph 235 of the *Recommendation by ICCAT amending the Recommendation 21-08 establishing a multi-annual management plan for bluefin tuna in the eastern Atlantic and the Mediterranean (Rec. 22-08),* in order to have greater transparency in implementing this Recommendation, the ICCAT Secretariat is mandated to biennially elaborate a report on the implementation of this Recommendation. this report is presented for the first time at the Annual meeting of the Commission in 2024.
